## Coalition for Physician Accountability Accepts Report and Recommendations from UME-to-GME Review Committee

Report and 34 recommendations released to the public

WASHINGTON, D.C. (August 26, 2021) The Undergraduate Medical Education to Graduate Medical Education Review Committee (<u>UGRC</u>), an independent body of stakeholders commissioned by the Coalition for Physician Accountability to review this important set of issues and formulate recommendations, has submitted its final report to the Coalition. The <u>report and 34 recommendations</u> to improve the transition from medical school to residency has been accepted by the Coalition and released to the public.

The release of the report marks the formal completion of the work of the UGRC. In transitioning the report of the UGRC to the Coalition, the Co-chairs shared the following statement:

"Over the past year, the UGRC worked tirelessly towards developing solutions to improve the UME-to-GME transition for all involved. We strove to follow a set of guiding principles that supported the public good and encouraged us to act boldly and transparently to address the challenges within the current transition. We believe the recommendations we put forward will create better organizational alignment across the transition, address inequities, enhance wellness and produce many additional positive outcomes.

The UGRC could not have completed its work without the invaluable input and feedback we received from the public and stakeholder organizations throughout the past year. The conversations we had and comments we received from students, program directors, DIOs, medical school deans, medical educators, international medical graduates, and the public had a profound impact in guiding our work and informing the final recommendations.

On behalf of the UGRC, we thank the Coalition for the support in conducting this important work, the independence afforded in drafting its recommendations, the acceptance of the report and recommendations and the commitment of the individual Coalition membership organizations to move the recommendations forward. We encourage the organizations to act diligently and with a sense of urgency as we believe these recommendations will have a profoundly positive impact on the UME-to-GME transition once implemented.
